It is our plan that all pupils, in all year groups, will return to school full-time from the beginning of the Autumn Term 2021.

This risk assessment is intended to mitigate risk wherever possible. It has been created in line with the guidance published by GOV.UK which can be found <u>here</u> This guidance has been prepared with input from school leaders, unions and sector bodies and in consultation with PHE and the Health and Safety Executive (HSE). This is public health advice, endorsed by Public Health England (PHE). The guidance is also focused on how the Department for Education (DfE) expects schools to operate in this new context. This includes:

- school operations
- curriculum, behaviour and pastoral support
- contingency planning to provide continuity of education in the case of a local outbreak

We will keep this risk assessment under review and update as necessary.





The Lyceum School will take swift action when we become aware that someone who has attended has tested positive for coronavirus (COVID-19).


The UKHSA team has carried out a rapid Risk Assessment

Based on the advice from the health protection team, close contacts who have symptoms will be advised to take a PCR Test, a task which will not be undertaken by HNS Test and Trace. We would ask pupils and staff who are awaiting the results of PCR tests to wear face coverings and take extra precautions until the results are known.

Household members of those contacts who are sent home do not need to self-isolate themselves unless the child, young person or staff member who is selfisolating subsequently develops symptoms.

If the test result is positive, they should inform their setting immediately, and should isolate for at least 10 days from the onset of their symptoms (which could mean the self-isolation ends before or after the original 14-day isolation period). Their household is no longer required to self-isolate if they have been double vaccinated or are aged under 18 years but should the family member test positive they will should self-isolate for at least 14 days from when the symptomatic person first had symptoms, following <u>'stay at home: guidance for households</u> with possible or confirmed coronavirus (COVID-19) infection'
